 TAX LEVY
 ORDINANCE NO. 621-02

AN ORDINANCE OF THE MUNICIPALITY OF MURRYSVILLE, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA FIXING THE TAX RATE FOR THE YEAR 2003

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of the Municipality of Murrysville, County of Westmoreland, Commonwealth of Pennsylvania

That a tax be and the same is hereby levied on all real property within the Municipality of Murrysville subject to taxation for the fiscal year 2003 as follows:

Tax rate for general purposes, the sum of 7.75 mills
 On each dollar of assessed valuation or the sum of775 cents
 On each one hundred dollars of assessed valuation.

Tax rate for road improvement purposes, the sum of500 mills
 On each dollar of assessed valuation or the sum of050 cents
 On each one hundred dollars of assessed valuation.

For debt purposes, the sum of 2.10 mills
 On each dollar of assessed valuation or the sum of210 cents
 On each one hundred dollars of assessed valuation.

For fire equipment purposes, the sum of60 mills
 On each dollar of assessed valuation or the sum of06 cents
 On each one hundred dollars of assessed valuation.

For hydrant purposes within 600 feet, the sum of200 mills
 On each dollar of assessed valuation or the sum of020 cents
 On each one hundred dollars of assessed valuation.

The same is summarized in tabular form as follows:

Tax Rate for General Purposes	7.75 Mills	.775 Cents
Tax Rate for Road Improvement Purposes	.50 Mills	.050 Cents
Tax Rate for Debt Purposes	2.10 Mills	.210 Cents
Tax Rate for Fire Equipment Purposes	.60 Mills	.060 Cents
Tax Rate for Hydrant Purposes	<u>.20 Mills</u>	<u>.020 Cents</u>
TOTAL	11.15 Mills	1.115 Cents
